







### B WOULD YOU PREFER READY-TO-MOVE-IN PROPERTIES OR UNDER-CONSTRUCTION PROPERTIES?




### WHAT SEGMENT OF PROPERTY ARE YOU CONSIDERING PURCHASING REAL ESTATE IN DELHI NCR?


